Information That We Collect

We will collect personal information from you when you complete a form on this website to make a booking, make an enquiry or subscribe to a service. We will also collect personal information from you if you book by telephone, via email or in writing.

The information we collect may include your title, name, home address, email address, telephone number and where applicable, business name, business address, business email address and phone number. If you choose to pay by credit or debit card then the necessary payment details will be collected through a secure payment gateway. We do not store or otherwise process your credit card details directly.

We do not collect any special personal data (such as health, disability, race, etc.) unless you wish to make us aware of special circumstances where it may be necessary to make reasonable adjustments at a venue or provide for special dietary needs.

How We Use This Information

It is necessary for us to collect the personal information of customers who agree to purchase our training courses, services or exams in order to run our business and provide and receive payment for those courses and services effectively. We take all necessary measures to ensure the privacy and confidentiality of the information collected.

How We Store Your Information

Our data and the data we collect are stored on a secure server based in the United Kingdom. How Long Do We Retain Information

We retain personal data relating to payments, VAT, tax and accounts for the minimum statutory periods required by UK law.

We retain information relating to historic bookings and purchase to enable us to analyse the performance of the business over time and plan for the future success of the company. We only keep this information for as long as is necessary to perform this task.

Passing Information to Third Parties

We will not sell, trade, transmit or otherwise pass on your personal information to a third party, except where it is necessary to deliver our services (such as personal details to Awarding Organisations for the purposes of exam/assessment registration or uploading of personal details to JAUPT for the purposes of DCPC)

The Use of Cookies

Overseas Data Transfer
